




# Ongoing Development of Social Emotional Learning

initiatives district- wide, such as Responsive Classroom, Peacemakers, middle school advisory programs and staff training on identification of student substance use and trends.

**Health Curriculum grades 3-9** with emphasis on enhancing physical, mental and emotional well being of all students and making healthy choices. Use of "High





Status Peers" in 8th Grade Health Classes, Recovery Panels in Senior Wellness (formerly called PE) and inclusion of substance use prevention lessons in all Wellness classes grades 9-12.



SBIRT (Screening, Brief Intervention, and Referral to Treatment) for 7th and 9th grade students, an opportunity to have a conversation with a school nurse about substance use, reinforcing healthy decision making.



In the community: Parent training and education: Right Under Your Nose mock bedroom display at Long Meddowe Days, free Narcan trainings at multiple locations in the community, community-based forums presenting up-to-date information on local substance use trends and community-based resources.



Co-hosted Town Hall Meeting with LPS Special Programs Committee: "If They Had Known" featuring a resource fair with local social service agencies, an expert panel discussion, and a free Narcan training, the film was also shown in each 12th grade PE class. Join one of our subcommittees!

During remote learning, we partnered with Health/Wellness classes at LHS and developed the film montage, "What I did During Covid-19" to share what pro-social activities youth and their peers were doing to overcome the challenges of the pandemic.



Capitol Hill Day: On February 5th, a group of CLOSE Community members including 7 student leaders from LHS' Students Against Negative Decisions (STAND) visited with Congressman Richie Neal, Senator Elizabeth Warren and Senator Ed Markey's Offices in Washington DC as part of the Community Anti-Drug Coalitions of America (CADCA) 30th Annual National Leadership Forum, Students, CLOSE Board Members, and LPS Wellness Teachers all spoke passionately about the value of investing in primary substance prevention.



# Our LHS School Climate Survey shows...

Since 2013, over 90% of LHS students have participated in a School Climate survey each spring. This survey enables us to identify emerging trends and to target our health curriculum and interventions to the needs and concerns of our students. This year's data was collected in the

early stages of the remote learning transition at the middle schools and LHS, so it may alter what information we collected by virtue of who filled out the survey, and when they completed it. In some data charts below comparisons are made to statewide data reported in the Massachusetts Youth Risk Behavior Survey, noted as MA YRBS.





# **Healthy Choices**


MOST LHS students make healthy choices pertaining to substance use MOST of the time. In our 2020 survey, when LHS students were asked about use in the past 30 days (an indicator of

# regular, current use):

- 68% had not used alcohol
- 86% had not used an e-cigarette
- 86% had not used marijuana
- 83% had not binge drank
- Over 99% had not misused Rx medications (opiates, sedatives or stimulants)

#### **Progress and Protective Factors**


2020 LHS students report:

- Strong connections with caring adults (90% report at least one LHS staff member they connect with; 85% feel they are treated with respect by staff
- A sense of belonging with peer group (89% of students report there are students at LHS "with whom I fit in")
- Students who reported that their parents thought it was wrong/very wrong for them to use substances and whose parents had clear rules had significantly lower use rates than their peers.

# Vaping sees a 50% decrease in 1 year

From 28.5% of LHS students reporting vaping in the last 30 days to 14%. Here's what helped...

 Students Together Against Negative Decisions (STAND) implement a "Vaping Illness Tracker" prominently on LHS bulletin board to show the status of EVALI (ecigarette/vaping product use-associated lung injury), while updating the numbers regularly.




#### Alcohol use has decreased since 2013:

**Risk Factors and Areas of Concern** 



Mental Health: 36% of LHS Students report experiencing symptoms associated with an anxiety disorder in the past 12 months. 24% report symptoms associated with depression, 19% report symptoms associated with an eating disorder. CLOSE continues to support the district's Social Emotional Learning efforts, access to counselors and development of community resources as they are vital to addressing these needs.




**Vaping:** While LHS student cigarette use remains low, the use of Electronic Nicotine Delivery Systems (ENDS) (such as the Juul or Phix) has increased dramatically in

keeping with a national trend. 20% of students felt there was no to slight risk of harm from ENDS use. 14% of LHS students report using ENDS in the past 30 days, and 5% report daily use of ENDS. 77% of daily ENDS users also use marijuana regularly; and they were 4X more likely to be daily marijuana users.




Marijuana: After a sharp increase in marijuana use from 2017-2018, we have seen a decrease in reported 30 day use the last 2 years. 4% of students report daily use. Students who reported marijuana use in the past 12 months noted the following: feeling tired, groggy or unmotivated (50%), coughing or breathing

problems (40%), spending too much money on it (35%) and procrastination (30%), problems remembering things (30%).

### **Driving Under the Influence**

Since our survey started in 2013, LHS Students have exercised more caution than their counterparts throughout the state when it comes to driving impaired by alcohol. In 2018, we asked about driving under the influence of marijuana. Given that the risk of being involved in a fatal crash doubles with marijuana impaired driving, our results are very concerning. Ongoing collaboration with law enforcement, parents, educators and students is underway to identify strategies for reducing this risky behavior.
